Mr Tan will be based in Singapore and Chongqing initially and will relocate to Chongqing early next year.

Before joining Ying Li, he was Group CEO of Surbana Corporation and prior to that, COO of Surbana Corporation and concurrently CEO of Surbana Land Pte Ltd. Surbana is a premium international building consultant with deep expertise across the whole real estate value chain as well as a developer of large scale residential township projects in China. As the founding CEO for its property development business, Mr Tan pioneered the setting up of the township development arm in Surbana and transformed the company into a leading foreign township developer in China. Mr Tan had previously held various appointments in the Housing and Development Board and the Ministry of National Development.

As Group COO, Mr Tan will oversee the project management, conceptualisation and development of projects and property management functions in the Ying Li Group.
